## Green Heart

### Committee for Geelong unveils vision for market square transformation.

#### March 6, 2025

The Committee for Geelong has revealed an ambitious vision for the redevelopment of the Market Square site.

Following on from their submission to the City of Greater Geelong's Market Square Master Plan process, and developed over the past 12 months, the vision aims to create a vibrant city heart for Geelong. A place that restores the site to its former role as an open meeting place for the community in the heart of the city centre.

The proposed vision includes:

- the demolition of the existing shopping centre and refurbishment of the heritage buildings and clock tower on Moorabool, Malop and Little Malop Streets.
- the creation of a 5000 square metre green open public space, hosting weekend markets, live events, and extend the Little Malop St dining precinct across Moorabool Street.
- a high-rise apartment building on the current car park site, featuring over 300 apartments, car parking, and mixed-use spaces, which will deliver essential housing stock for Central Geelong.

The vision has been developed with the support of several Committee members, led by planning and design experts Tract Consultants with support from WT Partnership and Preston Rowe Paterson. Bringing their local knowledge and expertise to the vision, these project partners have helped the Committee for Geelong bring to life an ambitious and catalytic project that can stimulate wider investment and development within Central Geelong.

Michael Johnston, CEO of the Committee for Geelong, stated, "This is about getting back to the Committee's roots; bold and ambitious ideas to fuel Geelong's growth and economic prosperity."

"The revitalisation of Central Geelong requires just that, a bold and creative step. Our city centre needs to be opened up to create a better flow, linking the waterfront and Westfield, the Little Malop entertainment and cultural precincts, the health services precinct, and the Ryrie Street dining and retail strip."

"This vision provides this by creating the large public open space our city lacks. A meeting place. Somewhere that can be activated on weekends. A place that will bring people into the city centre."

"Geelong has many amazing spaces in the city; Johnstone Park, the Waterfront, and we will soon have Nyaal Bunyal Geelong Convention and Event Centre. What we don't have is a city heart, and there is only one location that makes sense for this to be located. There is no other site in Geelong located so centrally, sitting on a single title of land."

Johnston added, "The green heart will feed off the green spine, and create urban renewal that can accommodate increased residential living in Central Geelong. We know there are several projects that can't get off the ground in the current environment, and this is a circuit breaker, a project that would unlock over \$1 billion in investment."

"This concept is one that current Market Square owners could embrace, or it could be picked up by other interested parties. Given the scale of the project, it would feasibly need to be a public-private partnership, with all levels of government working alongside a development partner to bring this vision to life. But our work has shown that this is feasible and could be delivered."

Simon Loader, Senior Principal at Tract Consultants, commented, "Through visionary planning and inspired design, we are shaping a place where our past and future meet—an urban park that honours our history, enriches our present, and welcomes generations to come. This is more than a redevelopment; it is a legacy of connection, culture, and community.

Through these artistic impressions, we have transformed the Committee's vision into visual concept that brings to life a future where the Market Square site provides a dynamic, connected, and celebrated place for all members of our community."

Cam Hamilton, Managing Director of Hamilton Group, expressed his support, saying, "As a property owner in central Geelong, I am excited about the potential this project has to transform our city centre. The proposed green space and residential development will not only enhance the liveability of Geelong but also attract significant investment and economic growth. Additional investment in car parking in the centre of Geelong will support tenancies and help draw people back to the heart of the city."

City of Greater Geelong Mayor Stretch Kontelj OAM has re-opened dialogue with the Market Square owners with an understanding that close collaboration between all key stakeholders will be vital for the project's success.

"The redevelopment of Market Square is crucial for the revitalisation of our CBD. We need more people living in central Geelong, and a multilevel, mixed-use redevelopment of Market Square has the potential to transform the culture of our CBD."

"Now that Council have recommenced positive dialogue with Market Square's owners, we are keen to work with them and other key players to make this happen."

# Community Leadership

The Leaders for Geelong program is designed to cultivate and connect a diverse network of leaders who are passionate about shaping the future of the Geelong region.

The program provides a rich learning architecture that blends experiential activities, facilitated workshops, community engagement, and leadership development, ensuring participants gain the skills, insights, and relationships needed to make a lasting impact.

Now in its 19th year, the Leaders for Geelong program explores core leadership domains that support both individual and collective growth:

#### Place

Participants gain insights into the political, economic, social, technological, legal, and environmental forces shaping the Geelong region and beyond.

#### Connection

Participants build relationships with a diverse community of peers while deepening their connections across the Geelong region.

- Leadership as an Action
   Participants develop the confidence and practical skills needed to step into leadership roles wherever they are needed.
- Inner Development
   Participants enhance their self-awareness, resilience, and presence, recognising that effective leadership is shaped by their inner condition.

In the 2024/25 financial year, twenty-nine participants continued their Leaders for Geelong program, experiencing a range of events from July to December including:

- Arts and Culture night a VIP experience and performance of The Mousetrap at the Geelong Arts Centre
- Innovation and Creativity Day hosted by Deakin University
- Presentations to Inspire workshop conducted by Catherine Bell
- Equity and Wellbeing Day with presentations from organisations such as WorkSafe, Art of the Minds, and Geelong Community Foundation
- Project Presentation Breakfast
- Building Blocks of Leadership facilitated by Damien O'Malley
- Canberra experience hosted by the Deputy Prime Minister, Richard Marles MP
- Graduation event (held in conjunction with the Committee for Geelong's Annual Dinner)

### Community Projects

Each year, Leaders for Geelong participants work on a community-based project of regional significance. Each project has a Project Champion who is the representative of the organisation to whom the project is handed over for subsequent ownership and implementation. Additionally, the project teams are supported by an Alumni Mentor (Leaders for Geelong program Alumni).

### 2024 Projects

#### Active Geelong -'Move More' Directory for Workplaces

This project team created a free, online Active Geelong Move More Directory, to help workplaces recognise what their physical activity challenges are, develop a physical activity strategy, and access resources to help to get their workplaces more physically active.

#### Geelong Connected -Communities Social Impact Report

This project developed a well-researched, evidenced based and compelling social impact report that articulates the positive impact that Geelong Connected Communities has had on communities in the Geelong region.

#### Barwon Water -Creating New Employment Pathways

This project assessed the feasibility of a central employment agency that works with organisations in Geelong to provide school leavers with access to varied work experience and an opportunity to undertake a qualification over a 12-month period.

#### Lazarus Community Centre -What Works Best for Clients at Lazarus - Part 2

The 2023 Leaders for Geelong participants provided an evidence-based research report that assisted with grant applications and community exposure. In year 2 of this work, Lazarus Community Centre looked to build on this project and trial expanded drop-in nursing service and provide increased care to clients where they are.

#### Give Where You Live -Creating a Fairer Community Through Workplace Giving

The Workplace Giving Program is one of the largest fundraising streams for the Give Where You Live Foundation, however it has slowly declined in recent years. This project focused on reinvigorating the Workplace Giving Program, with the goal to increase workplace givers by 10% in the first year.

# 2025 Leaders for Geelong

The first half of the 2025 program has demonstrated strong progress and meaningful impact for the twenty-four current participants. The *Opening Retreat* in February brought participants together for two days of immersive learning and connection, and introduced the cohort to the opportunities and challenges facing the region, and included a session with Wadawurrung Woman Corrina Eccles to strengthen cultural awareness and connection to Country.

In March, the first Building Blocks of Leadership session, Leading Self, was delivered following a preparatory masterclass. This workshop focused on personal leadership, self-awareness, strengths-based approaches, growth mindset, emotional intelligence, and effective communication—equipping participants with the tools to align values with actions and lead authentically.

The program's Community
Days have provided valuable

Port. Participants reflected on

identity moving forward.

June marked the second *Building Blocks of Leadership* focus: *Leading Teams*. Preceded by a masterclass on fostering collaboration, building trust, and leveraging team strengths, this workshop offered practical tools for enhancing group performance and navigating the pressures of deadlines and deliverables.

Through these first six months, the program has created a strong foundation of knowledge, trust, and shared purpose among participants. The events to date have set the 2025 cohort up to focus on their community projects for the remainder of the year.

### Activate Leadership Program

The eight-week Activate Leadership Program was successfully delivered twice during the reporting period: from August to October 2024 and again from April to June 2025.

The refreshed program, offered through a dynamic blend of in-person and online sessions, explores contemporary leadership themes with a strong focus on practical application and personal growth. A key highlight of the program is the final group project, where participants collaborate to interview a regional community leader and present their insights—bringing their learning to life in a meaningful and engaging way.

Participation grew across both intakes, with seventeen emerging leaders completing the program in August-October 2024, followed by twenty participants in the April-June 2025 cohort.
